COOKIES POLICY

1. Introduction

This Cookie Policy intends to explain in a transparent and clear way, how we use the information that we collect from our users' navigation. It is in this spirit that this Cookie Policy details how, when and why we use cookies on our website.

The Event's Website uses cookies for the purpose of creating and analyzing statistics in order to allow a continuous improvement of the Event's Website

By continuing to explore Açoreana's DMC Event Website, henceforth we assume that the Data Subject has read carefully our Cookies Policy.

2. What are Cookies?

Cookies are files that have small pieces of information that are stored and downloaded into the Data Subject device whenever the Data Subject visits a website (and which usually have a unique identifier), reason why, in the case of Açoreana DMC, they will be used whenever the Data Subject visits [http://bportugal.acoreanadmc.com/].

Some of the Cookies will only be triggered if certain features are used, whereas Açoreana DMC may use other Cookies that will always be generated and used. In addition, Açoreana DMC and other external services may store permanent cookies, which are stored at the browser level in the Data Subject access equipment and are used whenever Data Subject re-visit the Event Website (and since they are defined as necessary for the correct use of the platform), as well as resorting to temporary session cookies that remain in Data Subject browser's cookie file until Data Subject leave the Website.

Data Subject can find out more about which Cookies we use from the list below. Açoreana DMC undertakes to update this listing, so it may not reflect at all times the Cookies actually in use.

We may also use web beacons, tags or scripts on our Event Website or in emails sent by Açoreana DMC, so that we better understand the usage patterns of our Event Website and whose results may be reported based on third party services, using individual or aggregated data

3. Why we use Cookies?

Cookies allow the Event Website to memorize information about the Data Subject, such as the Data Subject preferred language, location, recurrence of sessions and other variables that we consider relevant to make the Data Subject search experience much more comfortable and efficient.

Açoreana DMC uses 1 (one) type of Cookies on the Event's Website:

• Performance cookies

They are used anonymously for the purpose of creating and analysing statistics in order to allow a continuous improvement of the Website.

Açoreana DMC uses these cookies for the following reasons:

- a) For Analysis purposes: we use Google Analytics to better understand how customers are using the Platform to help with Website performance and design management. Google will save this information, so Data Subject can access the Google Privacy Policy at google.com/intl/pt/policies/privacy.
